

GROVE Neurodivergent Mentoring & Education's BEING ME Programme Terms & Conditions

1. SUMMARY OF KEY TERMS

PROGRAMME OUTLINE	
Contents of programme	10 week programme consisting of 10 x 1-hour sessions once per week. This is a UK service and participants must check the time zone, be aware of changes to clocks going forwards / backwards and ensure times work for their child before booking.
Time Zones and Session Times	BEING ME is delivered by GROVE Neurodivergent Mentoring & Education Ltd as a UK-based service. All session times are listed in UK time (GMT/BST). If you are joining from outside the UK, please check the session time carefully in your own time zone before booking. Participants are responsible for checking how UK time changes throughout the year, including when clocks move forwards or backwards for daylight saving time. Please ensure that the scheduled session times will work for your child before booking. Bookings confirm acceptance of the published session times, and changes to personal circumstances or difficulties attending at the booked time do not usually qualify for a refund.
Total payment due per BEING ME programme (whether paid in full or instalments)	The payment for BEING ME is due in advance: FUNDED RATE Payable if booked and/or funded by Local Authorities or schools or other professional organisations of any kind. Parents using direct payments or personal budget must pay this amount. £500 SELF-FUNDING RATES

	For self-funding families we offer BEING ME on a sliding scale because we want it to be accessible to as many young people as possible, whilst ensuring GROVE can continue developing & delivering neuro-affirming support. (a) £500 – Sustaining Rate For families who are able to pay the full programme cost. Choosing this rate helps sustain GROVE's work, ensures staff are paid fairly for their work & enables us to make lower-cost places available for other young people. (b) £375 – Supported Rate For families who need a reduced fee whilst still contributing towards the majority of the programme costs. (c) £250 – Accessible Rate This rate is intended for families on a low income or experiencing financial hardship, where paying a higher rate would make participation difficult or impossible. We offer this rate on a trust basis and don't ask for evidence of financial circumstances. If your family is able to choose one of the higher rates, your contribution helps make this accessible option available to others & ensures the future of GROVE's support. Payment must be made in UK £.
FUNDED SPACES - Deposit and Confirmation of Funding	£50 booking deposit is also required for places funded or commissioned by a third party, including (but not limited to) Local Authorities, schools, charities or other organisations. This reserves the participant's place whilst funding arrangements are finalised. Funding confirmation or payment from the family (if funding is declined and you choose to self-fund) must be received 14 days before the programme begins. If

	this has not been received, the place may be released and offered to another young person and the deposit will not be refunded. Once GROVE Neurodivergent Mentoring & Education Ltd has received the full agreed payment from the commissioning or funding organisation, the £50 booking deposit will be refunded in full to the original payment method. The booking deposit is non-refundable if: • Third-party funding is declined, withdrawn or not received. • The participant or person making the booking cancels their place for any reason. This includes cancellations due to changes in circumstances, illness, availability or where the participant decides not to attend.
SELF-FUNDING - Payment Options	The full programme fee must be paid before the BEING ME programme begins. When booking a self-funded space, families can choose their fee rate and payment option. Option 1: Pay in full The full programme fee is paid via Stripe at the time of booking. Option 2: Two-part payment: 50% of the programme fee is payable at the time of booking, with the remaining 50% payable on the 1st of the month in which the programme starts. A participant's place on the programme is only secured once the first payment has been received.

	The full programme fee must be received before the first session takes place. Payment plans do not represent payment for individual sessions; fees cover the participant's place on the programme as a whole, including preparation, resources and facilitation.
Cancellation	If you are purchasing as a consumer (please see paragraph 7 below) you may cancel the Contract within 14 days of the date of your registration via the Information and Booking Form.

2. APPLICATION OF TERMS AND CONDITIONS

- 2.1 These terms and conditions ("Terms") apply to our group programme: BEING ME: Knowing Myself, Valuing Myself, Being Myself ("Programme") operated by GROVE Neurodivergent Mentoring & Education LTD ("we" or "us"). By registering to be a participant in our Programme, you agree to the following Terms and that these prevail over any inconsistent terms or conditions contained, or referred to, elsewhere or as implied by law, trade custom, practice or course of dealing.
- 2.2 The agreement is between us and you, the person or entity registering the child/young person to be a participant in the Programme ("you") and which is subject to these Terms ("Contract"), shall come into effect upon us emailing you to confirm our acceptance of your registration for the Programme and shall continue until terminated in accordance with these Terms.
- 2.3 If you are booking online, the booking process will be as follows:
- (a) add the Programme to the cart and follow steps as directed;
 - (b) make the payment
 - (c) complete the booking form within 48 hours of booking;
 - (d) If at any stage you have made an error in your order, you may email us at finance@gr0ve.org to correct any errors.
- 2.4 If you need us to invoice any other party to fund the programme please email jess@gr0ve.org to reserve a space at which point and invoice will be generated. This will need to be paid in full at least 7 working days before the start of the programme.
- 2.5 If you are booking online, you should print a copy of these Terms for your records as we will not be filing a copy and we may change these Terms from time to time.

- 2.6 These Terms should be read in conjunction with our Website Terms of Use, Privacy Policy and Acceptable Use Policy (all of which can be found on our website www.grOve.org ("site")).
- 2.7 Any content posted or submitted by you to our site or in our forum or any contribution on group sessions in the course of the Programme is subject at all times to the Acceptable Use Policy.
- 2.8 Where you are a corporate entity, a Local Authority or school, "you" as used in these Terms shall be deemed to include your officers and employees and you shall procure that such officers and employees fully comply with these Terms.

3. PROGRAMME

- 3.1 The Programme consists of 10 x weekly online sessions as detailed on the site, confirmation email and BEING ME Parent/Carer Guide.
- 3.2 **GAPS IN THE PROGRAMME:**
- (a) Please check the details on the site, confirmation email and BEING ME Guide to see if there are any planned gaps in the programme.
- 3.3 **SESSIONS CANCELLED BY US:** When a session is cancelled due to unforeseen circumstances the end date of the programme will be automatically extended and this will be communicated to you via email. If you are unable to attend no refund will be offered but access to the recording will be available.
- 3.4 **DATE/TIME OF SESSIONS:**
- (a) The date and time of all sessions are as set out on the site or as otherwise communicated to you, but are subject to change. We will provide you with as much notice of any change as is possible but we shall not be liable to you in any way for any change to such dates or times. Please check your emails regularly for updates on changes to dates and times.
 - (b) Group sessions shall start and end at the scheduled times regardless of the time that you join the session. If you are late for a group session, the session will not be extended and we shall not be obliged to refund you any amounts in relation to such session.
- 3.5 **CHANGES TO MENTOR:** If we need to make a permanent change the Mentor(s) we will endeavour to provide 2 weeks notice before any change is made. From time to time, we may need to make a temporary change to the Mentor(s) by substituting another GROVE Mentor to cover any of the sessions. We endeavour to provide as much notice as possible if this is necessary.
- 3.6 **MENTOR NON-ATTENDANCE/LATENESS/TECHNICAL DIFFICULTIES:**
- (a) If either Mentor is unable to attend, then the session may run with only 1 Mentor.
 - (b) In the unlikely event that both Mentors runs late or experience technical problems before or during the session then we will ensure that you are offered an opportunity to make up the time either:
 - (i) By extending the current session if mutually convenient;

(ii) By extension to a subsequent session;

(iii) By offering an additional session.

- (c) If you do not hear from your Mentor within 15 minutes of the start of your session please contact mentoringsupport@grOve.org - it may be that your Mentor is dealing with a risk of immediate harm/danger to another child/young person in which case your Mentor has to follow our safeguarding procedures to contact emergency services *before* letting parents/carers of sessions know about lateness or cancellation.

3.7 ATTENDANCE: We understand that for many of our children/young people full and regular attendance may be challenging. We want to support you and your child/young person if they are struggling to attend. Please speak with your Lead Mentor directly first and if need be, also email jess@grOve.org so that we can support. **Unfortunately, we cannot refund any of the Programme fees for non-attendance.**

3.8 UNPLANNED NON-ATTENDANCE: Please email your Mentor in the event of unplanned non-attendance – this enables us to be sure your young person is safe. Your young person's attendance is voluntary, they will not lose their place if they cannot attend individual sessions. If we can do anything to support their attendance and comfort please do ask – we want this to be a positive, supportive and safe environment for them. **Unfortunately, we cannot refund any of the Programme fees for non-attendance.**

3.9 GENERAL COMMUNICATION WITH YOUR LEAD MENTOR: Your Mentor is always your first point of contact and short email communication with them is encouraged. For anything more please book a meeting with them.

3.10 BOOKING A PARENT/CARER/GUARDIAN MEETING WITH YOUR MENTOR: If you wish to book a 15 minute, 30 minute or 1 hour meeting with your child/young person's Mentor then please contact your Mentor directly and also copy mentoringsupport@grOve.org in. Meetings are charged at £50 per hour (pro rata). Meetings can take place on Microsoft Teams, by telephone or via text chat – please inform your Mentor of your preference. Please note that GROVE respects your child/young person's right to confidentiality so Mentors will not discuss specific aspects of your child/young person's Mentoring sessions or experiences without their prior permission. You will be invoiced for the time booked even if you do not use the entire time this is because the Mentor will not be able to book additional work during that time. Please note that if the time is exceeded you will be invoiced for that additional time also – your Mentor will remind you of this during the meeting when you are nearing the end of your booked time.

3.11 BOOKING WORK ASSOCIATED WITH EHCP's, MEETINGS WITH PROFESSIONALS or SUCH-LIKE: Any work associated with professionals (such as EHCP reports, reviews or any work of a similar nature) is payable at £50 per hour charged in increments of 15 minutes. This work must be booked in advance with a minimum notice period of 2 weeks and is subject to availability. Please communicate with GROVE's Director Jess Garner on mentoringsupport@grOve.org . Meetings will need to be online or by telephone as we cannot travel in person to attend. For meetings, you will be invoiced for the time booked even if you do not use the entire time this is because the Mentor and/or Director will not be able to book additional work during that time. Please note that if the time is exceeded for meetings, you will be invoiced for that additional time also. For written work we will supply an estimate of time needed and ask you to accept this before we proceed, if whilst completing the work this estimate changes, we will seek your approval before continuing. Please note

we will not be able to communicate with professionals without your explicit permission and also your child's if they are 13 or over. We will also not discuss specific aspects of your child/young person's Mentoring sessions or experiences without their prior permission.

3.12 **SAFEGUARDING:** The parent/carer/legal guardian must always remain in the house. You do not need to be present during the session but must ensure you are nearby, and we suggest the child is in a room that does not have a closed door. It is the parent/carer/legal guardian's sole responsibility for enforcing this.

- (a) Sessions are always recorded for safeguarding and insurance purposes - please refer to our Privacy Policy providing further details.
- (b) We must verify your child's identity before their first session if they are not going to be using their camera or do not intend initially to use their camera – you will be offered different ways of doing this but regretfully, we will not be able to work with a young person if we cannot verify their identity.

4. **ONLINE SESSIONS: *Including required software/hardware and data protection***

- 4.1 You agree to keep user details and your password for the site, your video call account and any communication forum (e.g. our Facebook group) confidential at all times and to not disclose them to any third party. You must notify us immediately if you become aware of any unauthorized use of your account and you shall indemnify us against all claims, damages, losses, costs or expenses (including professional fees) and any other liability which arises from any unauthorized use of your account. In using our Facebook Group, you agree to comply with our Acceptable Use Policy that you can view at <https://grOve.org/acceptable-use-policy/>.
- 4.2 You are required to have access to a personal computer with sound, microphone and video capability, reliable internet connection and the capability to access Microsoft Teams in order to access the programme.
- 4.3 From time to time we may supply complimentary copies of resources via password protected access to areas of our website or via email. We protect our hardware and software with anti-virus and malware protection.
- 4.4 The online sessions of the Programme are held on third party secure servers and we have taken all reasonable steps to ensure that the online content will be available at all times during the course of the Programme but in the event that such content (or any content added by you or other participants in the Programme) is not available in whole or in part at any time, or becomes corrupted, is deleted or is failed to be stored, we shall have no liability in any circumstances.
- 4.5 You agree to keep user details and your password for the site confidential at all times and to not disclose them to any third party. You must notify us immediately if you become aware of any unauthorized use of your account and you shall indemnify us against all claims, damages, losses, costs or expenses (including professional fees) and any other liability which arises from any unauthorized use of your account.
- 4.6 You are required to have access to a personal computer with sound, microphone and video capability, reliable internet connection and the capability to access Microsoft Teams in order to access the programme.

- 4.7 From time to time we may supply complimentary digital items such as PDF copies of resources via password protected access to areas of our website or via email. We protect our hardware and software with anti-virus and malware protection.

5. PAYMENT

- 5.1 The total price payable for the Programme is as set out in the summary of key terms above and depends on how the programme is funded.
- 5.2 If you are self-funding your place, payment must be made either in full at the time of booking or through the agreed two-part payment option.
- (a) Where the two-part payment option is selected, 50% of the total Programme fee is payable at the time of booking, with the remaining 50% payable on the 1st of the month in which the Programme begins. The two-part payment option is a payment arrangement only and does not divide the Programme into separate purchases. By selecting this option, you agree to pay the full Programme fee. For the avoidance of doubt, the Programme fee is payable for the participant's place on the Programme as a whole and is not payment for individual sessions. If a participant withdraws from the Programme or chooses not to attend after booking, the remaining balance will still become due on the agreed payment date and the full Programme fee remains payable, except where these Terms and Conditions state otherwise.
 - (b) Where a payment arrangement has been agreed, any subsequent payments will be invoiced in accordance with the agreed payment schedule and must be paid by the stated due date.
- 5.3 For funded or commissioned places, a £50 booking deposit is payable at the time of booking to secure the participant's place while funding arrangements are completed.
- (a) This deposit will be refunded in full once GROVE Neurodivergent Mentoring & Education Ltd has received the full agreed payment from the funding or commissioning organisation.
 - (b) Funding confirmation or payment from the family (if funding is declined and you choose to self-fund) must be received 14 days before the programme begins. If this has not been received, the place may be released and offered to another young person and the deposit will not be refunded.
 - (c) The booking deposit is non-refundable if:
 - (i) Third-party funding is declined, withdrawn or not received.
 - (ii) The participant or person making the booking cancels their place for any reason. This includes cancellations due to changes in circumstances, illness, availability or where the participant decides not to attend.
- 5.4 Where payment is the responsibility of the parent/carer (whether self-funding or as holder of direct / personal budgets or any such-like arrangement), any sum payable under these Terms and Conditions which is invoiced and remains unpaid for more than 3 days after the due date shall, without prejudice to any other right or remedy available to GROVE Neurodivergent Mentoring & Education Ltd, entitle GROVE to:

- (a) charge interest from the due date until payment is received at a rate of 4% above the base rate of the Bank of England from time to time in force; and/or
- (b) suspend the participant's access to the Programme until payment has been received or the Contract is terminated.
- (c) If payment is not received within 7 days of the due date, admission to sessions may be paused until payment is made.
- (d) If payment is not received within 14 days of the due date, admission to sessions may be terminated. Termination of participation does not affect the participant's liability to pay any outstanding fees due under this Contract.
- (e) The full Programme fee must be paid before the Programme begins.

5.5 Where the Programme is being funded by a Local Authority, school, charity or other commissioning organisation, invoices are payable within 30 days of the invoice date unless otherwise agreed in writing.

5.6 Confirmation that funding has been approved and payment arrangements are in place must be received 14 days before the Programme begins. Where such confirmation has not been received by this date, GROVE Neurodivergent Mentoring & Education Ltd reserves the right to withdraw the participant's place and offer it to another young person and the deposit will not be refunded.

- (a) Where an invoice remains unpaid after 30 days, GROVE reserves the right to charge interest from the due date until payment is received at a rate of 4% above the base rate of the Bank of England from time to time in force and/or to pursue recovery of the outstanding debt by any lawful means.
- (b) Termination of a participant's place or completion of the Programme does not affect the commissioning organisation's liability to pay any outstanding fees due under this Contract.

5.7 The total price payable as set out in the summary of key terms is exclusive of Value Added Tax (and any other applicable taxes or duties) which shall be added at the applicable rate where necessary.

5.8 All payments are non-refundable other than as set out in paragraph 7 below.

6. OUR OBLIGATIONS

6.1 We warrant to you that the Programme is of satisfactory quality and reasonably fit for the purpose for which the Programme is supplied.

6.2 Other than as set out in paragraph 6.1 above, all warranties and representations are excluded to the fullest extent permitted by law. Due to the nature of peer groups and mentoring and the fact that success is dependent on a number of factors over which we have no control, we do not guarantee any particular results.

6.3 We will endeavour to ensure that all information that we provide is accurate and up-to-date but we shall not be liable for any claims arising from such information being inaccurate or not up-to-date or otherwise.

6.4 You acknowledge that in the course of the Programme you and your young person may have access to other Programme participants confidential information and you agree not to use or disclose to any third party such confidential information. This restriction does not apply to:

- (d) any use or disclosure authorised by you or required by law;

- (e) any use or disclosure which you consider necessary or advisable in order to prevent illegal acts or harm to others; or
- (f) any information which is already in, or comes into, the public domain otherwise than through your unauthorised disclosure.

7. **OUR OBLIGATIONS CONT': CANCELLATION:** If you are purchasing a Course or programme as a consumer as defined in the Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013 – namely you are buying the course as an individual acting for purposes which are wholly or mainly outside of your trade, business, craft or profession and not and not using funding linked to an EHCP, personal budget, EOTAS/EOTIS, or any other third-party funding source, then the following terms apply:

- (g) **IF THE PROGRAMME BEGINS IN MORE THAN 14 DAYS:** you have the right to cancel this agreement within 14 days of the date of this agreement (this means the date you booked via submission of the Information & Booking Form or by online purchase) by emailing us at finance@gr0ve.org. To meet the cancellation deadline, it is sufficient for you to send your communication concerning your exercise of the right to cancel before the cancellation period has expired. If you cancel this agreement, we will reimburse to you all payments received from you in relation to the agreement within 14 days after the date on which we were informed about your decision to cancel this Contract; and
- (a) **IF THE PROGRAMME BEGINS WITHIN 14 DAYS:** notwithstanding paragraph 7(a) above, you agree that we may begin the supply of the programme before the end of the cancellation period set out in paragraph 7 (a) above and you acknowledge that you will lose your cancellation rights in relation to such content:
 - (i) If we are able to reallocate your place, we will refund you minus any applicable bank or transaction fees.
 - (ii) If we are unable to reallocate your place, no refund will be issued but we may be able to offer a space on a later programme subject to availability. Access to video recordings will remain available as per 9.
- (h) in relation to the provision of any additional services under this Contract (see 3.10 and 3.11):
 - (i) you hereby request immediate performance of the Contract and acknowledge that you will lose your right of withdrawal from the Contract once the service contract is fully performed; and
 - (ii) if you cancel the Contract before the services have been fully performed, you agree that you will pay for the supply of the service for the period for which they are supplied. The amount payable will be in proportion to what has been supplied, in comparison with the full coverage of the Contract.

8. **DATA.** You acknowledge that your own and your child's personal data will be processed by and on behalf of us as part of us providing the Programme to you in accordance with our Privacy Notice that you can view at [Privacy Policy | GROVE \(gr0ve.org\)](#).

8.1 **RECORDINGS:** Our online group sessions are recorded for internal purposes but also to allow participants to revisit the content for a limited time. Recordings will be made available only to the participant who booked the session, for the duration of the programme and a period of **7 days** following the final session date.

- (a) By participating, you agree to the following conditions:
 - (i) The recording is for **personal viewing only** by the registered participant.
 - (ii) You **must not share**, download, screen record, take screenshots of, or distribute the recording in any form.
 - (iii) You agree to **respect the privacy and confidentiality** of all other participants featured in the session.
 - (iv) Breach of these terms may result in removal from future sessions and/or further action where necessary.

9. INTELLECTUAL PROPERTY

- (a) We are the owner or the licensee of all Intellectual Property Rights and all other rights in the Programme and all content within the Programme and nothing in these Terms or otherwise shall operate to transfer the ownership of the Intellectual Property Rights in the Programme or the content of the Programme to you or to any other person.
- (b) You may not at any time copy, reproduce, publish in any form, share, sell, dispose of or otherwise make available to a third party in any way any of the content or materials (or any of the ideas and concepts created by us and contained in the content or materials) contained in the Programme.
- (c) Use of our logo is strictly prohibited without our prior written consent.
- (d) You may not without our prior written consent make any audio or visual recordings of any part of our Programme.
- (e) The provisions of this paragraph 7 shall survive termination of the Contract.

10. TERM AND TERMINATION

- (a) The Contract shall continue until the end of the Programme when the Contract shall expire other than for the Terms that are specifically stated to remain in force.
- (b) Notwithstanding the provisions of paragraph 7, either of us may terminate the Contract on written notice to the other with immediate effect if at any time:
 - (i) The other commits any serious or repeated breach or non-observance of any of the provisions of these Terms; or
 - (ii) The other (i) makes a resolution for its winding up, (ii) makes an arrangement or composition with its creditors, (iii) makes an application to a court of competent jurisdiction for protection from its

creditors, (iv) is unable to pay its debts, (v) ceases trading or an administration or winding-up order is made or an administrator or receiver is appointed in relation to such party, (vi) is declared bankrupt or (vii) is convicted of a custodial offence (other than a road traffic offence); or

- (iii) The other party commits any fraud or dishonesty or acts in any manner which in the opinion of the terminating party brings or is likely to bring the terminating party into disrepute or is materially adverse to the interests of the terminating party.

- 10.2 We may terminate the Contract without any liability to make any refund to you if your continued participation in the Programme is in our opinion causing disruption to the running of the Programme or to other participants.
- 10.3 On or before the date of termination of the Contract, you shall immediately pay any unpaid fees or other sums payable under these Terms (which for the avoidance of doubt shall include any remaining instalments regardless of the point at which the Contract is terminated).
- 10.4 Termination of this agreement shall not affect the accrued rights, remedies, obligations and liabilities of either of us as at the date of termination of this Contract, including the right to claim damages in respect of any breach of the Contract which existed at or before the date of termination.
- 10.5 Any delay by us in exercising our right to terminate the Contract shall not constitute a waiver of our right to terminate or to seek any other remedy.
- 10.6 Paragraphs which expressly or by implication have effect after termination of the Contract shall continue in full force and effect after the date of termination of the Contract.
- 10.7 This paragraph 11 shall survive termination of the Contract.
- 10.8 Where the Contract expires, this shall be treated as a termination for the purposes of paragraph 8.7 and all other paragraphs that refer to “termination”.

11. LIABILITY

- 11.1 Nothing in this paragraph 11 shall limit our liability for death or personal injury caused by our negligence or for our fraud or fraudulent misrepresentation or for any matter for which liability cannot be legally excluded or limited.
- 11.2 We shall not be liable for any loss of profits, loss of business, depletion of goodwill and/or similar losses, loss of anticipated savings, loss of goods, loss of contract, loss or corruption of data or information or any special, indirect, consequential or pure economic loss, costs, damages, charges or expenses suffered or incurred by the you as a result of you entering into the Contract and/or us providing the Programme.
- 11.3 Our total liability in contract, tort (including negligence or breach of statutory duty), misrepresentation, restitution or otherwise arising in connection with the performance or contemplated performance of the Contract shall in all circumstances be limited to the price paid by you for the Programme.

- 11.4 Any claims to be brought under or arising out of the Contract must be brought within 6 months of the date of the event giving rise to the claim.
- 11.5 If we are prevented from or delayed in performing our obligations by your act or omission or by any circumstance outside of our control (including our illness or incapacity or that of any member of the team involved in providing the Programme), we shall not be liable to you for any costs, charges or losses sustained or incurred by you that arise directly or indirectly from such prevention or delay.
- 11.6 We may make changes (and shall not be liable for any additional costs incurred by you or for any other liability incurred by you as a result of changes) in (i) the Programme, (ii) any other content, (iii) the time and date of sessions or (iv) the delivery mode of the sessions (for example changing an in person session to an online session) (v) trainers, instructors or coaches.
- 11.7 The provisions of this paragraph 9 shall survive termination of the Contract.
- (a) You acknowledge and agree that:
 - (b) The Contract constitutes the entire agreement and understanding between us and supersedes any previous arrangement, understanding or agreement between us relating to the provision of the Programme (which shall be deemed to have been terminated by mutual consent);
 - (c) in entering into the Contract you have not relied on any undertaking, promise, assurance, statement, representation, warranty or understanding (whether in writing or not) of any person (whether party to the Contract or not) relating to the provision of the Programme other than as expressly set out in the Contract.

12. GENERAL

- 12.1 By registering for our Programme you warrant that:

- 12.8 The Contract is personal to you and you may not assign, transfer, charge, subcontract, sub-license or deal in any other manner with all or any of your rights under the Contract.
- 12.9 We may transfer, assign, charge, sub-contract or otherwise dispose of a Contract, or any of our rights or obligations arising under it, at any time during the term of the Contract.
- 12.10 If we fail to insist upon strict performance of any of your obligations under the Contract, or if we fail to exercise any of the rights or remedies to which we are entitled under the Contract, this shall not constitute a waiver of such rights or remedies and shall not relieve you from compliance with such obligations. A waiver by us of any default shall not constitute a waiver of any subsequent default. No waiver by us of any of these Terms shall be effective unless it is expressly stated to be a waiver and is in writing.
- 12.11 If any of these Terms are determined by any competent authority to be invalid, unlawful or unenforceable to any extent, such term, condition or provision will to that extent be severed from the remaining terms, conditions and provisions which will continue to be valid to the fullest extent permitted by law.
- 12.12 A person who is not a party to the Contract shall not have any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of the Contract.
- 12.13 The rights of the parties to terminate, rescind or agree any variation, waiver or settlement under the Contract are not subject to the consent of any person that is not a party to the Contract.
- 12.14 The Contract and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with English law.
- 12.15 We each irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with the Contract or its subject matter or formation (including non-contractual disputes or claims).
- 12.16 Unless the context otherwise requires, a reference to one gender shall include a reference to any other gender.
